TENDER DOCUMENT

In pursuance of the approved Action Plan of afforestation programme for the year 2021-22 in Phulbani Forest Division it is required to procure vermi compost for use in ANR gap plantations over 4000 hectare under CAMPA-APO-2021-22 and 2335 hectare under MGNREGS 2021-22 scheme.

Eligibility of person to submit tender for vermicompost :-

1. The invitation to participate in the Tender is open to all who produces and sells pure vermicompost/ castings of approved quality with production unit within the State of Odisha. The participation fee for the tender is Rs.1000/- (+) GST 180/- total Rs.1180/- . The Tenderer has to deposit Rs.1180/- in favour of DFO, Phulbani Forest Division in shape of Demand draft to participate in the Tender. The above fees are **non-refundable**.
2. The Tenderer may purchase the Tender paper from the O/O-DFO, Phulbani Forest Division on working days on deposit of above fees of Rs.1180/- in shape of demand draft or download from district NIC website and attach the above fees in shape of Demand draft for Rs.1180/- to participate in the Tender.
3. Besides, participation fees, the Tenderer has to deposit EMD of Rs.10000/- (Rupees Ten Thousands) only in shape of Demand Draft in favour of DFO, Phulbani, which shall be refunded to un-successful tenderers immediately after closure of tender.
4. The supplier must not have been banned or black listed by any Government organization.
5. There must not be any adverse action pending against the supplier on the quality of the product.
6. The supplier must have valid GST Registration, PAN and Tax clearance certificate up-to 31.3.2021.
7. The Self Help Group (SHG) producing vermi compost are also eligible to participate in the tender. The SHG group has to deposit Rs.1180/- in shape of Demand draft in favour of DFO, Phulbani Forest Division to participate in the Tender.

Terms & Conditions

1. All participating Tenderer has to attach EMD of Rs.10000/- (Rupees Ten Thousands) only in shape of Demand Draft purchased in favour of DFO, Phulbani and payable at Phulbani. The details of the EMD shall be mentioned in the Technical Bid also; otherwise their bid shall not be qualified for the tender. The EMD shall be refunded immediately to unsuccessful bidders.
2. The successful tenderer shall also furnish a security deposit @1% of the total bid amount duly pledged in favour of the Division Forest Officer, Phulbani Forest Division in shape of Demand draft only drawn on any nationalized bank at Phulbani. This Security deposit shall be returned after complete delivery of the materials.
3. The tenderer or his authorized representative shall produce sample of their material before the tender selection committee.
4. The Technical bid/Financial Bid shall be opened on 30th June 2021. Financial Bid shall be opened after approval of Technical Bid.
5. **Initiallay, the successful Tenderer shall deliver 50% of the approved material. After checking by the Tender Selection Committee, if found suitable, the rest 50% material shall be delivered. If the quality found un-suitable, the Tender awarded shall be cancelled and no amount shall be paid to the Tenderer, besides the EMD and Security Deposit shall be forfeited to Govt.**
6. The cost of material furnished in the bid document shall be inclusive of transportation Charges and Taxes admissible if any.
7. All payments to the Tenderer shall be made after completion of delivery of approved quality of vermi compost after adjusting the EMD and Security Deposit.
8. All documents and Original Tender paper should be signed by the Tenderer with date.
9. The Decision of the Tender Selection Committee of Phulbani Forest Division shall be final.
