- 5. All mechanical & technical specification details of the plant must be attached with item wise clearly.
- 6. The successful bidder shall submit Performance guarantee (in the form of DD/FD/TD duly pledged in favour of District Planning Officer, Purnea) which will be 5% of total supply cost.
- 7. The district administration reserves the right to cancel the bid or distribute the supply order to more than one bidder without explaining reason of the same.
- 8. Bidder can participate in the bid for whole equipments.
- 9. Technical specifications of the aforementioned list of items should be as per guidelines of M/o Health and Family Welfare/ICMR/BMSICL.
- Payment shall be made only after the successful completion of supply by the agency and approval of the same from District Health Society Purnea.

(B) Financial Bid:-

- 2. All rates quoted by the Bidder shall be inclusive of GST, any other taxes, and transportation charges etc, relating to the supply.

- 4. The selected agency will be responsible for supplying materials to the place where administration will ask to supply in the Purnea District.
