Subject:- COVID-19 - Imposition of restrictions under Section 144 Cr.PC and Section 34 of Disaster Management Act 2005 thereof.

ORDER No 36 - DMK of ADM 2020
Dated:- 22-03-2020

Whereas, restrictions were imposed under Section 144 Cr.PC on Public gathering of more than five persons and movement of public transport throughout the District vide this office Order No. 34-DMK/Adm of 2020 Dated:-19-03-2020; and

Whereas, Govt of J&K vide order No.60-FCS&CA of 2020 Dated:-22-03-2020 has declared the following services as essential services within the Union territory of J&K:-

- a) Supply of Groceries (Wholesalers and Retailers)
- b) Supply of Fresh fruits and vegetables (Mandies and Retailers)
- c) Dispensing of Petrol/Diesel at Pumps.
- d) Milk Shops and Dairies and related products.
- e) Supply of Cattle feed and fodder.
- f) Medicines and other pharmaceuticals(Retailers, Wholesalers and Manufacturing)
- g) Banks and ATMs.
- h) Supply of LPG (domestic and commercial)
- i) Health services (Including movement of staff thereof).
- j) Manufacturing of Health and Medical equipments
- k) Telecom Operators and their designated agencies.
- l) Newspapers
- m) Post offices
- n) Loading and unloading of Wheat and Rice at FCI and State Food depots.
- o) Transportation of Essential Commodities through National and State Highways (Petrol, Diesel, Kerosen, Milk, Vegetables, Fruits , Groceries, FCI supplies etc.
- p) Provision of Electricity, Water Supply and Municipal and Sanitary services (Including movement of staff thereof).

Whereas, Chief Secretary of J&K vide Communication No. PS/CS/19/2020 Dated:-22-03-2020 has issued specific directions for shutdown of all establishments /services except essential commodities /services in the UT of Jammu and Kashmir from Sunday 22nd March 2020 (8:00 PM) till Tuesday 31st March 2020 (6:00 PM)

Now therefore in continuation of restrictions imposed vide this office order No:-34 DMK/Adm of 2020 Dated:-19-03-2020 and by virtue of powers vested under Section 34 of the Disaster Management Act 2005, I District Magistrate Kupwara do hereby further order that :-

1. There shall be restrictions on movement of Public within the jurisdiction of the District Kupwara except for essential commodities or for accessing emergency medical care.
2. There shall be complete restrictions on assembly of more than three persons at any of the Public places within the District.

3. There shall be restrictions on both Public and Private transport anywhere within the jurisdiction of District Kupwara.
4. All shops Hotels and other commercial establishments shall be completely closed and there shall be no activity in these establishments except those relating to essential services mentioned above.
5. All Magistrates within their respective jurisdictions shall liaise with the Police Counterparts and ensure compliance of these instructions while simultaneously facilitating availability and Supply of Essential Commodities including Ration, LPG and Grocery items to the general Public.
6. AD Food Civil Supplies and C.A Kupwara shall regulate distribution of Ration, LPG and Groceries directly to the households of the consumers to avoid any movement of public during the period of restrictions.
7. Addl. Deputy Commissioner Kupwara shall ensure adequate arrangements/Permits for persons/ vehicles engaged in providing in essential services to travel without hindrance to their place of work, after due authorization from undersigned.
8. Sr Superintendent of Police Kupwara / Handwara shall ensure wide publicity of this order within their respective Jurisdictions and ensure compliance in letter and spirit.


The order shall remain in force w.e.f 8:00 PM on 22-03-2020 till 6:00 PM on 31st March 2020.

However, essential services/officers/staff and vehicles deployed for Administration and management of Quarantine facilities shall be exempted from the purview of this order.
