Subject: Withdrawal of Preliminary Notification issued under the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement act 2013, for the construction of PMGSY road in Sub-division Karnah.

Reference order: 30-DIVCOMK-LAS OF 2021 dated: 06-02-2021

Whereas, the ministry of law and justice (legislative department) vide the Jammu and Kashmir reorganization act, 2019 repealed the land acquisition act, Smvt, 1990 and made applicable the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement act 2013.

Whereas there has been difficulty in processing the cases of land acquisition under the implementation of new act as no rules have been finalized by the government yet in this regard.

Whereas one committee of officers was constituted by Divisional commissioner Kashmir vide order 30-DIVCOMK-LAS Of 2021 dated 06/02/2021 for preparing comprehensive details with respect to implementation of "The right to fair compensation and transparency in land acquisition and resettlement act, 2013 in UT of J&K and suggest the rules to be incorporated and same are forwarded to the government for further course of action.


Hence in the light of above captioned references, Preliminary Notification issued by this office under the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement act 2013, for construction of PMGSY Roads vide no
