**Subject:** Containment and Management of Covid-19 (Coronavirus)-declaration of Red Zones thereof.

**ORDER**

In view of prevailing situation due to pandemic of COVID-19 and in pursuance to powers vested in me under the Epidemic Diseases Act, 1897, the Disaster Management Act-2005 and under Section 144 Cr.PC, I, Imam Din District Magistrate Kupwara do hereby order as under,

1. That, the hamlet "Khan Mohalla/Mir Basti Jabba" of Village Batpora Hayhama Tehsil Kupwara is declared as Micro Red Zone and consequently there shall be no inward or outward movement of any person from the Zone and the people shall stay indoors.
2. Further the surrounding hamlets of "Khan Mohalla Mir Basti jaba Batpora" are declared as Buffer Zones and the inhabitants of these areas shall also restrict their movement and shall not allow visitors to visit their homes without written permission of Administrator concerned.
3. Tehsildar Kupwara shall act as Administrator for Red and Buffer Zones declared as indicated above. The Administrator shall be assisted by Mr. Showket Ali Khan Master BHS Batpora Hayhama (Contact No.9596486737).
4. The Administrator/Assisting Officer shall ensure screening of Households in the Red Zone and furnish information as per the prescribed format to this office by 1:00 Pm on daily basis.
5. The Administrator/ Assisting Officer shall conduct survey of co-morbid & old age people in the area and ensure their sampling in coordination with BMO concerned and consequently report to COVID-19 Control Room Kupwara on daily basis.
6. All the officers of the line departments shall ensure the availability of basic facilities including food grains, LPG, medicines etc. in the Red/Buffer Zones. They shall promptly respond to medical emergencies and concerned BMO shall dedicate one ambulance for the Red Zone area.
7. The SHO concerned shall ensure barricading at all the entry points of Red Zone to prevent inward and outward movement as per the guidelines.
8. Two (2) additional surveillance teams shall be deployed to cover all households in the Red Zone through door to door screening and sampling in the next four days.

Any person/group/organisation found involved in breach of this order shall be booked under relevant laws.
