Subject:- COVID Containment Measures and Restrictions thereof.

ORDER

In compliance to Govt. order No:- 49-JK(DMRRR) of 2021 Dated:- 11-07-2021 and in continuation to this office Order No:- DCK/PS/2021/04/7193-7202, Dated:- 05-07-2021 and in exercise of powers vested in me under Section 144 Cr.Pc and Section 34 of Disaster Management Act, I Imam Din (KAS) District Magistrate Kupwara do hereby order that :-

01. Weekend Curfew from Friday 8:00 PM till Monday 7:00 AM and daily night curfew from 8:00 PM till 07:00 AM shall continue to remain in force .
02. All outdoor Shops and Bazaars are permitted to open on five days in a week (except on Saturdays and Sundays) subject to following of all COVID related SOP's.
03. 50% Shops of the in indoor shopping complexes/Malls can open subject to a roster to be issued by concerned Tehsildar/ Market President.
04. Restaurants can open for in-dining from 07:00 Am till 10:00 Pm at 50% of its total capacity, only for the customers who are vaccinated or are carrying a negative RT-PCR or RAT report of 48 hours prior. The owners/staff/managers of the establishments shall ensure compliance to it.
05. Essential Services as permitted in order dated:- 30-05-2021 shall be allowed.
06. All Schools and coaching centers in the District shall continue to remain closed for imparting on-campus/in-person education to students of all classes till 31-07-2021.
07. Vaccination drive shall be intensified and public transport are encouraged to take measures for entry/access facilities only to the vaccinated people or if a person is not vaccinated, shall carry valid COVID negative test report within 48 hours prior to availing such facilities.
08. There shall be strict adherence to COVID appropriate behaviors and defaulters shall be firmly dealt as per the relevant Disaster Management Act and Indian Penal Code.

Moreover, the teams constituted by the concerned Tehsildar's shall submit daily report regarding activities carried out by them and their assessment of compliance level.

This order shall remain in force till further orders.
