Whereas, the District Health Society Kupwara vide Notification No: 04 of 2021 dated: 10-06-2021 invited applications on prescribed format from the residents of District Kupwara possessing the prescribed qualification i.e. B.Sc nursing from Govt. recognized Institute or matric with Diploma in Junior Staff Nursing training from SMF or any other recognized institute.

whereas, in response to the above said Notifications, the District Health Society received 133 applications; and whereas, after security of the documents by the constituted team of experts, The candidates in whose case the deficiency of documents has been noticed were advised through notice vide DIPK:8246/21 to submit their deficient documents as shown against their names in the below table in the office of Convener (District Health Society) Chief Medical Officer Kupwara within 05 (five) days from the date of issuance of this notice.

Whereas on receipt of various representations from the applicants for the extension of the date for the submission of pending documents, which was given 05 days in the previous notification. By taking a lenient view in the demands of the applicants, it has been decided that seven (07) days extension will be given to the candidates who had failed to deposit their pending documents yet from the date of publication of this final notice, failing which their candidature shall be out rightly rejected without any further notice and they will not be allowed to appear in the written examination.
