Subject:- COVID Containment Measures and restrictions thereof.

## ORDER

In compliance to the Govt order No:-03-JK(DMRRR) of 2022 Dated:- 09-01-2022 and in continuation to this office order :- DCK/PS/2022/04/88-98 Dated:- 08-01-2022 and in exercise of the powers vested in me under section 144 Cr.PC and Section 34 of District Management Act, I **Imam Din (KAS)** District Magistrate, Kupwara do hereby order that:-

1. The Daily Night Curfew from **09:00 PM till 06:00 AM** shall continue to remain in force
2. The maximum number of people permitted to attend any indoor/outdoor gathering shall be strictly **restricted to 25**.
3. All Colleges, schools, Polytechnics, ITIs, Coaching Centres for civil Services/Engineering/NEET etc. shall **adopt online medium of teaching** and there shall be **no in-person teaching**.
4. The Educational Institutions shall be permitted to direct attendance of vaccinated staff for **administrative purposes only**. The Head of the institutions shall ensure that the guidelines related to Social distancing and **COVID Appropriate Behaviour (CAB)** are strictly followed
5. There shall be strict adherence to COVID appropriate behaviour and defaulter shall be firmly dealt as per the relevant Disaster Management Act and India Penal Code.
6. Meeting with all Aimmah of Masjids be conducted to ensure social distancing, 100% usage of masks including Sanitizers/Soaps in all Masjids and the Aimmah be also requested to advice the public to ensure strict adherence to **COVID Appropriate Behaviour (CAB)** and Social distancing including avoiding of gatherings at other places as well. In the Prayer Halls of Masjids, there shall be alternate marking on floor for Social distancing while offering Salah.
7. Market Associations shall ensure strict adherence to Social distancing, 100% usage of masks including Sanitizers/Soaps and **COVID Appropriate Behaviour (CAB)** in the markets and gatherings at shops shall not be allowed.
8. All the positive Cases must be kept under home Quarantine and be strictly monitored on daily basis by the District Control Room as well as Block Level Control Rooms.
9. The services of Masjid Committees/ PRIs of Various levels/ VLWs/Patwaries /Lumberdars /Chowkidars including Aganwardi and Aasha Workers be also utilized for mass awareness.

Moreover, the teams constituted by the concerned Tehsildar's shall submit daily report regarding the activities carried out by them and their assessment of compliance level.

This order shall remain in force till further orders.
