Subject: - **Regarding Formalities/Procedure of Events like Shobha Yatra/Nagar Kirtan etc.**

1. **FORMALITIES**

The following documents are required for issuance of permission of events like Shobha Yatra/Nagar Kirtan etc. having gathering beyond 500 (five hundred people) in U.T. Chandigarh: -

- a) Application alongwith affixing court fee stamp @ Rs.5/- per day.
- b) A copy of booking of ground/space from the concerned competent authority.
- c) A copy of identity card of the applicant like Aadhar Card etc.

It is further clarified that the Chandigarh Administration has earmarked the Rally Ground, Sector-25, Chandigarh for holding rallies/dharnas etc. Therefore, the permissions are not being granted by this office in U.T. Chandigarh except Rally Ground, Sector-25, Chandigarh only after completion of the same formalities and procedure as required for the events stated above.

2. **PROCEDURE**

On receipt of application alongwith above mentioned required documents, this office obtain the NOC/Reports from the concerned authorities like SSP (Law & Order), SSP (Security & Traffic), Chief Fire Officer and NOC regarding booking of grounds/space from the Municipal Corporation/Estate Office etc. on event to event basis.

After completion of required documentary formalities and receipt of NOC/Reports from the concerned authorities, this office issues the permission to the applicant within the stipulated period as prescribed in the Right to Service Act applicable in U.T. Chandigarh.


