ORDER

Whereas, certain labs have been authorized to conduct tests for COVID-19, it has become eminent that Standard Operating Procedures and guidelines be followed by them to prevent the risk of spread of infections.

Whereas, it has been noticed that laboratories are not taking details (Name/Mobile No./Address) of every person being tested which makes it difficult to trace them if they test positive. Therefore, it becomes a threat to life of all persons because of the risk of the spread of infections.

Whereas, it has also been noticed that sample collection centres are not sharing information if a person provides address of a place outside Haryana and gets himself sampled/tested for COVID-19 inside Haryana.

Whereas, for public safety sample collection centres are required to give a formal intimation in this regard to the concerned area CMO/ Civil Surgeon/District Magistrate/Health Secy. of the State mentioned in the address informing them that this person is being sampled /tested for COVID-19 here in Faridabad and who has stated his address to be in your State and the result of the test be also intimated to them.

Therefore, I, Yashpal, IAS, District Magistrate, Faridabad in exercise of powers granted to me by virtue of Section 144 of Code of Criminal Procedure, do hereby prohibit labs in district Faridabad from collecting samples without following due process and SOPs as enlisted below. Labs collecting samples are directed to mandatorily follow this SOP:-

- While collecting the samples for COVID-19 the personal details (Mobile No/Name/Address) of every person being tested be obtained and a phone -call be made there & then on the Mobile no so provided in order to establish the veracity of the personal details so provided and the sample collection staff be properly sensitized to ensure the same before extracting the sample. In absence of phone number, a copy of a government-issued photo ID Card with address (eg. Aadhar) mandatorily be taken.
- If a person provides address of a place outside Haryana and gets himself sampled/tested for COVID-19 inside Faridabad, then a formal intimation in this regard be sent to the concerned area CMO/ Civil Surgeon/District Magistrate/Health Secy. of the State mentioned in the address informing them that this person is being sampled /tested for COVID-19 here in Faridabad and who has stated his address to be in your State and the result of test be also intimated to them.

These orders shall be enforced by Incident Commanders, CMO or any other officers assigned duty for this purpose and any violation of the same shall be strictly dealt with as per section of 188, 269, and 270 of the Indian Penal Code, 1860, relevant Disaster Management Act, 2005 and Epidemic Act, 1897.



These orders are being issued ex-parte because of emergent situation created due to prevalence of the Corona epidemic.

The order shall be promulgated by uploading it on the District website, circulated it through WhatsApp groups, and on other mediums of social/digital media. Whenever the same is not possible through these methods, means of mass communication like radio, television may also be used and publicity vans be also deployed to disseminate the same.
