**ORDER S**  
Bishnupur, the 22<sup>nd</sup> September, 2021.

No.10/151/COVID-19/2021-DCB: Whereas, in continuation and also in partial modification of Order of even number dated 21/08/2021, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 in his capacity as Chairperson, State Executive Committee of the State Disaster Management Authority vide Order of even number dated 21/09/2021, hereby orders in respect of the entire State to be **in force for thirty days w.e.f. 22/09/2021 to 21/10/2021.**

2. Whereas, there is an emergency and circumstances do not permit the serving of notice in due time upon the public, this order is passed ex-parte under Sub-Section 2 of Section 144 of Cr. P.C. 1973 and is directed to the public in general.

3. Now, therefore, **I, Shri Hanjabam Bobby Sharma**, Additional District Magistrate, Bishnupur District, Manipur in exercise of power conferred under **Sub-section 2 of Section 144 of Cr.P.C. 1973, hereby order the following in respect of Bishnupur District to be in force for thirty days w.e.f. 22/09/2021 to 21/10/2021.**

- i. **Night curfew from 8.30 p.m. to 4.00 a.m.**
- ii. Markets/keithels may open with 50% capacity ensuring adequate physical distance between them and all of them wear masks.
- iii. Restaurants and cafes are allowed to open from 10 am to 8 pm subject to ensuring Covid Appropriate Behaviour and also ensuring that the customers inside the eating area do not exceed 50% of the capacity of the restaurants/cafe.
- iv. Banks, Insurance Offices and Postal Offices may function normally without the shortened working hours stipulated earlier.
- v. Public transport buses are allowed to ply with passengers not exceeding 50% capacity of the bus. All passengers, Driver and Helper shall wear mask and Police shall ensure that the capacity limit is complied with.
- vi. **List of activities permitted remains unchanged except the above.**
- vii. **SOCIAL GATHERINGS/FEASTS ARE NOT PERMITTED.**

**The whole revenue jurisdiction of Bishnupur District.**

Any persons/Organisation/Institution found violating this Order shall be deemed to have committed an offence punishable under Section 188 and other relevant section of the Indian Penal Code.
