RULES

S. R. O. No. 347/2019.—WHEREAS, it appears to the Government of Kerala that the land specified in the Schedule below is needed or likely to be needed for a public purpose, to wit for the land acquisition for setting up Industrial Park by KINFRA in Kannur District;

AND WHEREAS, in exercise of the powers conferred in sub-section (1) of section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013

(Central Act 30 of 2013), Government of Kerala have decided to conduct a Social Impact Assessment Study in the area specified in the Schedule below;

Now, THEREFORE, sanction is accorded to the Social Impact Assessment Unit, Rajagiri outreach, Rajagiri College of Social Sciences, Rajagiri P. O., Kalamassery to conduct a Social Impact Assessment Study and to prepare a Social Impact Management Plan as provided in the Act. The process shall be completed within a period of 8 weeks in any case.
