WHEREAS, the Government of Kerla have as per GO(Rt) No 3377/2018/RD dated 14/08/2018 appointed the Special Tahsildar (LA), Kalliad, Kannur to perform the functions of a Collector for the purpose of land acquisition under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

AND WHEREAS, the Government hereby appoint Deputy Collector (LA), Collectorate, Kannur as the Administrator for the purpose of Rehabilitation and Resettlement to the proposed acquisition.



AND WHEREAS, it appears to the Government that the land specified in the Schedule below is needed or is likely to be needed for public purpose to wit for the land acquisition for establishing International Research Institute of Ayurveda, Kalliyad, Kannur.

Now, THEREFORE, notice is hereby given to that effect to whomsoever it may concern, in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

All persons interested in the said land are accordingly required to lodge before the Special Tahsildar (LA), International Research Institute of Ayurveda, Kalliyad within 15 days from the date of publication of the above notification or after giving public notice regarding this whichever is later, a statement in writing of the objections, if any, regarding the updation of land records or title in respect of the land proposed for acquisition. Any objections/statement which is received after the due date or which does not clearly explain as to how the objector is interested in the land is liable to be summarily rejected.

SUMMARY OF SOCIAL IMPACT ASSESSMENT REPORT

The primary impact of the project is the loss of land and losses of residence to 267 and three title holders respectively. Twelve title holders/PAPs loss their agriculture crops. Three all seasonal drinking water sources and a small pond are also coming in the acquiring land. But compare to the area of acquiring land the above impacts are minor and able to mitigate by compensation and rehabilitate the three families who are displaced. In the cases of displacement of cultural properties (cemetery of three community groups) the resettlement is little difficult and the impact may not be able to reduce much after the mitigation measures. A consultation with the cultural groups and develop strategies to resettle the cemeteries is the best possible mitigation measure at this state otherwise Govt. can exempt the cemetery area from the acquisition. Ninety five percentage of the acquisition area is rocky land and several authorised and unauthorised brick cutting mining units are functioning. Rain water is stored in



some of the ponds which are abandoned after mining. These water sources are not benefited to the inhabitants. Many rare species of plants especially herbs are growing here. The requisition agency can able to do special studies on this and develop plans to preserve the herbs and rare species. The livestock of the nearby households depends the vegetation of the area and the acquisition will cut the chances of rearing animals. But this will not affect the stock of the livestock in the area. While considering the category of the land for compensation the quarry lands will be termed as special category. Setting up a committee and address the grievance of the people before preparing the land acquisition sketches may reduce the grievance and improved community participation. No major or notable environmental impact anticipated due to the acquisition. Rehabilitation and resettlement of three families who are displaced from the area, resettle the cemeteries of three community groups or exempt it from acquisition and compensate the other loss of title holders will effectively mitigate the impact.

The land of 167 people who got 5 cents to 25 cents of land from government as part of Social welfare measures are also affected by the project. No one in the above beneficiaries of social welfare measure of the government, build houses in the distributed land. Therefore the purpose of the land distribution is not met. Out of the total 167 beneficiaries 64 give their land for bricks cutting by receiving money. The analysis of the economic situation of these families shows that 141 families will improved their economic condition from the time of receiving of land. But eleven families are still economically vulnerable. Special care and attention to this people in acquisition process will mitigate the impact.

Eleven plot of land is identified as neither belongs to government nor with any family or individual. Preparing the sketch of these lands at the earliest will bring transparency. The land transactions after the notification of SIA study will be closely monitored before disbursement of compensation.

In the north-west part of the project area a natural stream was flowing and the small pounds in the stream are the major water source for the families living nearby. But flow of this stream was blocked due to the bricks cutting. Project will take measures to rejuvenate this stream and it may help to reduce the impact of shortage of water sources.

The project is treated as framed for a public purpose under the Right to Fair Compensation and

Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules has come in to force on 19.09.2015 and as per Rule 18 notifying the details of the land proposed to be acquired, categorising them separately as rural or urban areas is required.

The notification is intended to achieve the above object.
