**ORDER**

In compliance of the directions issued by Haryana State Pollution Control Board C-11, Sector-6, Panchkula No. HSPCB/Misc./2020/894-917 Dated 03.12.2020 wherein it has been directed to ensure the implementation of the order of Hon'ble NGT dated 01-12-2020 (OA No. 249 of 2020) in letter and in spirit with immediate effect.

And whereas I am satisfied that for immediate compliance of the aforesaid order of Hon'ble NGT a complete ban is to be made on the sale and use of any kind of fire cracker in the District Bhiwani.

Therefore I, Jaibir Singh Arya, IAS, District Magistrate, Bhiwani do, hereby, order a complete ban on sale and use of any kind of fire crackers in the territorial limits of District Bhiwani, during Covid-19 Pandemic. This order shall remain in force till further orders.

Any violation of this order would be punishable under section 188 of IPC and Explosives Act 1884/Explosives Rules 2008 or any other provision applicable in this regard for the time being in force. In addition to the penal action compensation shall also be recovered from the violators of this order. Any victim of pollution, apart from other remedies, can approach the Office of undersigned for Compensation, by showing evidence of individual damage and the person responsible for the damage.

The Superintendent of Police, Bhiwani, Additional Deputy Commissioner, Bhiwani, All Sub Divisional Magistrates, City Magistrate, Bhiwani, DDPO, Bhiwani, All Tehsildars/Naib Tehsildars, DSPs, BDPOs, EO/Secy. Municipal Councils/Committees, SHOs of all police stations, Fire officer and other fire department staff of District Bhiwani shall ensure the compliance of this order. All officers are directed to conduct raids, alongwith SHO concerned, wherever it seems necessary and initiate penal action as warranted.

The District Public Relation Officer, Bhiwani shall give wide publicity to this order throughout the District Bhiwani and this order should also be sent to press for wide publicity DIO/ADIO is directed to post the order on official website [www.bhiwani.gov.in](http://www.bhiwani.gov.in).

It is not possible to serve this notice to the public at large individually, so in view of emergent situation, this order is passed ex-parte and is addressed to public at large.
