

**ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL
PROCEDURE 1973**

WHEREAS, the COVID-19 has been declared as pandemic by the World Health Organization and National Disaster Management Authority, being satisfied that the country is threatened with the COVID-19 pandemic.

Whereas, it is evident that there has been an exponential surge in the COVID cases in the District Bhiwani, and necessary measures are to be adopted to contain the spread of the COVID-19 and also to ensure that there is minimum collateral damage.

The Government of Haryana has considered it necessary to take effective measures to prevent and contain the spread of the COVID-19 virus in the state of Haryana including district Bhiwani in the interest of maintenance of public health, hygiene and safety.

Therefore, now, in exercise of the powers vested in me by virtue of Section 144 of Criminal Procedure Code 1973, I Rajesh Jogpal, IAS, District Magistrate, Bhiwani do hereby prohibit the gathering of more than four people in any public space, unless specifically permitted.

This order shall not apply to police force and other public servants on duty, persons of medical industries/institutions, persons working in sectors related to essential products/ services.


This order shall come into force with effect from 26.04.2021.



Any person contravening this order shall be punishable u/s 188 of Indian Penal Code. Superintendent of Police, Bhiwani shall implement this order and all police officers shall take suo-moto cognizance of the violation of this order.

It shall be published for the information of public in general through the press and publicity Van of public relations department and by affixing copies at notice board of all Offices of the district administration, Superintendent of Police office, District Courts, Deputy Commissioner, District Municipal Commissioner, Bhiwani, Sub Divisional Magistrate, Bhiwani/Loharu, Siwani and Tosham, Tehsil, Zila Parishad, Panchayat Samiti, all Police Station and other prominent places.
