

**District Magistrate –Cum- Chairperson District Disaster Management Authority Bhiwani**  
**Order**

In succession of this office letter no. 1228/camp/MB dated 23.04.2021. In Compliance of order No. DMC-SPO-2020/4863 dated 23.04.2021 and keeping in view the prevailing conditions due to COVID-19 pandemic in the District and in exercise of powers conferred under section 30 of Disaster Management Act 2005 and all other powers in this behalf enabling the undersigned to impose restrictions during COVID-19, it has been decided to regulate the timing of closure of shops/Commercial establishments in the large interest of public, health in the areas of Municipal Council, Bhiwani, Sub Division Bhiwani, Tosham, Siwani, Loharu in District Bhiwani are as under.

1. All Shops/ commercial establishments in the markets shall be allowed to operate up to 6:00 PM only.
2. All the Restaurants/Halwai shops/ Eateries/ Bakeries/ Confectionaries/ Cafes and other such like service providers including reharies and food vans shall remain open up to 06:00 PM only. There shall not be on-site dining facility after 06:00 PM. However, packing and take away/ home delivery service is allowed up to 09:00 PM.
3. All Shops exclusively selling Milk and Dairy products i.e Paneer, Cheese, Dahi, Ghee etc. shall remain open up to 06:00 PM
4. All Fruits and vegetables shop, including vendors/ hawkers, Grocery Shop, Egg/ Meat Shops and poultry shops shall operate up to 06:00 PM.
5. The chemist shops, emergency OPDs of registered medical establishments and petrol pumps shall remain open round the clock.
6. All Person above 65 years of age with co-morbidities, pregnant women and children below the age of 10 years are advised to stay at home except for meeting essential requirements and health purposes.
7. National directives for COVID-19 management and general preventive measures such as use of face mask, frequent hand washing and social distancing shall be followed religiously in all public places.

In addition to the above it has been observed that general preventive norms (social distancing/ wearing of masks etc.) and personal hygiene measures are not being followed in the whole sale Vegetable Market. It is directed that all persons shall follow social distancing, personal hygiene norms in the Vegetable Markets are followed strictly and avoid over-crowding.

All concerned stakeholders/ general public shall ensure strict compliance of the instructions and also follow the guidelines as issued by the Ministry of Home Affairs/ Ministry of Health & Family Welfare/ Government of India as well as Government of Haryana from time to time.

This order shall come into force with immediate effect.

The Superintendent of Police, Bhiwani, Additional Deputy Commissioner, Bhiwani, District Municipal Commissioner, Bhiwani, All SDMs-incident Commanders, All DSPs/ SHOs, EO/Secretaries, MC, Bhiwani, concerned BDPOs and any Officer/Official authorize by the under signed or theses officers shall strictly enforce the directions and take appropriate action against the persons(s) if found violation these directions as per section 51 to 60 of Disaster Management act 2005.

The District Information and Public Relations officer, Bhiwani shall give a wide publicity and disseminate this information through all mode of communication at every nook and corner of the district.
