**ORDER:**

The Revenue Divisional Officer, Warangal has reported that, the Vice Chairman, KUDA, Warangal has filed requisition for acquisition of lands in Village site to an extent of Ac.28-20gts in respect of Sy.No.538, 537, 539, 542, 545, 544, 551, 552,553, 559, 560, 554, 555, 556, 91, 82/5, 82/4, 82/3, 82/2, 82/1, 89, 83, 87, 86, 136, 139, 132, & 131 whose lands are coming under the acquisition for the purpose of formation of 200 feet Master Plan Bye-Pass / IRR Road from Khammam Road to Mulug Road connecting Narsampet Road situated at Gorrekunta village of Geesugonda mandal in Form-B in terms of the RFCT in LA R & R Act (Telangana Amendment) Act 2016 (Act 21/2017) read with the RFCT in LA & RR Act, 2016 (Act 30/2013).

Further, the RDO, Warangal has stated that, the District Collector, Warangal vide Proc.No.G/345/2019, dated 08-12-2020 has approved the Form-C Notification and published in newspapers dated 09-12-2020 and an award was pronounced to an extent of Ac.3-02gts leaving a balance of Ac.16-35gts as detailed below:

Further, the Revenue Divisional Officer, Warangal has reported that, the compensation paid to land owners for an extent of Ac.3-02gts for an amount of Rs.5,91,57,320/-, further requested to the Vice Chairman, KUDA, Warangal to provide funds to an amount of Rs.28,84,13,320/- (Rupees twenty eight crores eighty four lakhs thirteen thousand three hundred and twenty only) for acquisition of balance extent of Ac.16-35gts, but the requisition department has not provided funds till date, due to which the date of notification in Form-C will be lapsed by 08-12-2021 and requested to extent the period of preliminary notification to one year w.e.f. 08-12-2021 to 07-12-2022 as per LA Act 2013, U/s.19 (7).

In view of the above circumstances, the Form-C has been extended for a period of (12) months w.e.f.08-12-2021 to 07-12-2022 as per LA Act 2013, U/s.19 (7).
