The above objections have been verified. On perusal, in respect of Junior Assistant category out of the (6) objections received, (3) are related to submission of bonafide study certificates i.e Sl.No.1,4 & 6 are above. As such they have no bearing on the marks obtained by the candidates in the graduation course. However their claim/objection is considered. The other (3) objections i.e Sl.No.2, 3 & 5 pertain to submission of marks memo of the graduation course. In respect of Typist category, (3) claims/objections have been received, of these, Sl.No. 1 and 3 pertain to age concession and correction in mobile no. which have no bearing on the marks obtained by the candidates in the graduation and their technical qualification.
