ORDER:

Vide ref. 5th cited, the RDO Adilabad has submitted that the following Preliminary Notifications has been expired and the delay in process has been occurred in land acquisition due to Municipal Elections and pandemic situation of Covid-19 and also the funds are not yet released from the concerned department and the pattedars also didnt come forward for giving willingness of the sparing land for formation of Road and hence requested for issue orders for extension of the preliminary notification to process land acquisition cases in the matter.

As per section 19(7) of RFCTLARR Act 2013 "where no declaration is made under sub-section (1) within Twelve Months from the date of preliminary notification, then such notification shall be deemed to have been rescinded".

Further, as per Sec. 19(7) of RFCTLARR Act 2013 "Provided further that the appropriate government shall have the power to extend the period of Twelve Months, if in its opinion circumstance exist justifying the same."

Vide ref. 1st cited, "the Government has appointed District Collector as "Appropriate Government" to initiate Land Acquisition proceedings for any extent of land to be acquired for a public purpose within the jurisdiction of revenue district."


Hence, in view of the above, as per Sec. 19(7) of RFCTLARR Act, 2013 and as per G.O. Ms. No. 6, Revenue (JA&LA) Department, Dt. 17.03.2017, orders are hereby issued for extension of the following preliminary notification issued for acquisition of land for construction of Interstate Lower Penganga Project Main Canal Bypass Road further for a period of (12) months as shown below:
