Sub: Land Acquisition – Minor Irrigation – Mission Kakatiya - Nigini (V) of Boath (M) – Acquisition of land for Construction of New Tank and canal – Preliminary Notification proposals U/s-11(1) of RFCTLARR Act 2013 – Approved – PN Period lapsed – Extension Orders - Issued

ORDER:

The RDO, Utnoor, vide ref.4th cited has stated that the Preliminary Notification in respect of the following case will be expired on 18.10.2020 and the delay in process occurred due to pandemic situation of Covid-19 and funds are not deposited by the concerned department so far, and hence requested for issuing orders extending the period of Preliminary Notification to process land acquisition cases further.

As per section 19(7) of RFCTLARR Act 2013 “where no declaration is made under sub-section (1) within Twelve Months from the date of preliminary notification, then such notification shall be deemed to have been rescinded”.

Further, as per Sec. 19(7) of RFCTLARR Act 2013 “Provided further that the appropriate government shall have the power to extend the period of Twelve Months, if in its opinion circumstance exist justifying the same”.

Vide ref. 1st cited, the Government has appointed District Collector as “Appropriate Government” to initiate Land Acquisition proceedings for any extent of land to be acquired for a public purpose within the jurisdiction of revenue district.

In view of the above, as per Sec. 19(7) of RFCTLARR Act, 2013 and as per G.O.Ms. No. 6, Revenue (JA&LA) Dept., Dt. 17.01.2017, orders are hereby issued for extension of the following preliminary notifications issued for land acquisition for construction of balancing reservoir further for a period of (12) months as shown below:
