ORDER:

Vide reference 2nd cited, the RDO, Adilabad has submitted the preliminary notification proposals in Form-VI for acquisition of land to an extent of Ac./Gts 45.25 for the land situated at Ponna (Vg) of Sirikonda (M) for construction of Tank and canal under Mission Kakatiya Phase - IV as per Section 11(1) of Right to Fair Compensation Transparency L.A R&R Act 2013 and submitted the copies of (i) Grama Sabha Resolution, (ii) Sub Division Record, (iii) Enjoyment Survey Report, (iv) Pahani Copies of Sy. No's and (V) Tonch map and also informed that the land coming under procurement is not coming Under Section 38-E of Ceiling Act 1973.

Further submitted that as per G.O.Ms. No. 32, I & CAD (LA .R & R/A2) Dept. Dt. 11.07.2019, the Project "Construction of tank near Ponna (Vg) of Sirikonda(M) under Mission Kakatiya Phase-IV (Sl. No. 12 in the list of tanks approved vide G.O.Ms. No. 32)" is exempted from the application of the provisions of the Chapter - II & III of RFCTLA& RR Act - 2013.

In view of the above and in exercise of the powers conferred U/s-3(e)(i) in Chapter-I and 11(1) in Chapter- IV of Right to Fair Compensation Transparency L.A R&R Act 2013 and in terms of orders issued by the Government of Telangana, Hyderabad vide G.O 1st read above, the Preliminary Notification proposals are hereby approved for acquisition of land situated at Ponna (V) of Sirikonda(M) for construction of Tank and canal under Mission kakatiya Phase - IV as per Section 11(1) of Right to Fair Compensation Transparency L.A R&R Act 2013 and for publication of the PN in official Gazette, (2) daily news papers in the local language, in the office of Collector/RDO and also to upload in the website of appropriate Government and publish in the affected areas as per Section 11(1) of Right to Fair Compensation Transparency L.A R&R Act 2013.

The DIO, NIC, Adilabad is hereby instructed to take immediate necessary action for uploading the preliminary Notification in the official website concerned without fail.
