Technician Gr.II and (39) ANM/MPHA (F) on out sourcing basis, against regular cadre strength of Pharmacist Gr.II, Lab. Technician Gr.II and ANM/MPHA (F), application down load from the Official website, after filling up may be sent to the District Medical & Health Office, Adilabad (District) either in person or by Register post from 08.11.2021 up to 12.11.2021 between 10:30 am to 5:00 pm on all working days. The last date of receiving applications is 12.11.2021 before 05.00 P.M. The Committee is not responsible for any postal delay and the selection committee reserves right for cancellation of notification at any level.

III. Age:

The minimum age is 18 years and the maximum age is 34 years.

The minimum and maximum age shall be reckoned as on 01.07.2021 with the following reservation allowed for reckoning the maximum age limit as per rules in force:

For S.Cs. S.Ts & BCs 5 (five) years

For ex-service men 3 (three) years in addition to the length of service in armed forces

Disabled persons 10 (ten) years

For 10% reservation to Economically Weaker Section (EWSs) vide G.O.Ms.No.65 GA(SER.D) Dept. Dated.19.03.2021

IV. METHOD OF RECRUITMENT FOR STAFF NURSE, PHARMICIST GR. II LAB. TECHNICIAN GR.II AND ANM/MPHA(F)

Recruitment shall be done by the District Selection committee.

Selections will be done based on the following criteria:

- (i) Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for the age. Weight-age for age will be reckoned from 18 years of age of the candidate. 0.5 mark will be awarded for one completed year of age with a maximum of 10 marks. The age will be reckoned as on 01-07-2021.
- (ii) Provisional list and Merit list will be prepared based on the marks criteria and displayed on Official website of transparency and also for calling objections.
- (iii) Selections list will be prepared from the finalized merit list duly following the Rule of Reservation (ROR) and Presidential Orders.

Rule of Reservations (ROR)

- (i) Rule of Reservations in respect of Community, Disability, Ex-Service Men/Women, EWSs shall be strictly observed as ordered by the Government of Telangana from time to time.
- (ii) The Rule of Reservations to local candidates is applicable as per the Presidential order as per newly created District i.e. New Adilabad Circular Memo No. 3112/SPF.I/2021, Dated.22.7.2021 of General Admn. (SPF.I) Dept. Govt. of T.S.


V. How to Apply

- (i) Self-attested copies of the following Certificates should be enclosed along with the application form:

1	S.S.C or Equivalent examination.
2	Intermediate or 10 + 2 examination.
3	Qualifying Examination Pass Certificate.
4	Marks Memos of all the years (qualifying examination)
5	Registration Certificates of respective Councils
6	Latest Caste Certificate issued by the Tahsildhar/MRO concerned
7	Study certificate for the years from 1 th class to 10 th class and in Case of Private study residence certificate from the Tahsildhar/MRO concerned.
8	PH certificate in respect of candidates claiming reservation under PH Quota.
9	Relevant certificates in respect of candidates claiming Ex-service Men Quota.
10	EWSs eligible candidates submit certificate not below the rank of Tahsildar
11	1 Photograph duly pasted on the application form.
12	Acknowledgement Card.
