The District Collector, Guntur vide reference 3<sup>rd</sup> cited, constituted 3 committees consisting of One Asst. Commissioner of Labour concerned and one Officer from Industries Department in each Team.


The committee inspected the industries on 20/08/2021 and 21/08/2021 and submitted report. The copy of report is appended with this notice.
