



OFFICE OF THE COLLECTOR AND DISTRICT MAGISTRATE: KEONJHAR

Order No 1203 /Judl. Dt. 17.05 / 21

Keeping in view, detection of COVID-19 positive case/cases in Ward No.03(Bedhasahi) **under Keonjhargarh Municipality** of Keonjhar District, **the same is declared as containment zone** as per the provision contained in Section 6(2) (i) of the Disaster Management Act, 2005 & section 2, 3 & 4 of the Epidemic Diseases Act, 1897 read with the Odisha COVID Regulation, 2020 as per the guidelines issued by Govt. of Odisha vide No.1663/R&DM (DM)/Dt.31.03.2021 for containment of COVID-19 for taking detailed measures for contact tracing and contain spread of disease.

**The following points around containment zone are declared as sealing points:**

**The East West Road passing in front of the house of Sri Benudhar Das and includes all the houses beyond it till the end of the Lane.**

Now, therefore, in the larger interest of public and with a view to contain the spread of COVID-19 it is hereby ordered to implement the following directions.

- a) Only essential activities shall be allowed.
- b) There shall be strict perimeter control to ensure that there is no movement of people in or out of the micro- containment zones, except for medical emergencies and for maintain supply of essentials goods and services. The supply of Essentials and medical requirements will be made through **Executive Officer, Keonjhargarh Municipality through Eastern Blockade point.**
- c) There shall be intensive house to house surveillance by surveillance team.
- d) Listing of contacts shall be carried out in respect of all persons found positive, along with their tracking, identification, quarantine & follow up contacts for 14 days (80% of contacts to be traced in 72 hours) .

The **Executive Officer, Keonjhargarh Municipality** is hereby directed to open a control room in his office with dedicated help line number for any requirement of essential commodities like grocery & medicine.


