NOTE

- This register must be maintained on a daily basis and shall be subject to inspection at any time by the observer appointed by the Election Commission, the District Election Officer/ Returning Officer or by any other officer authorized in this behalf.
- The register must be lodged in original with the district election officer as the return of election expenditure under section 78 of the Representation of the People Act, 1951. It must be accompanied by an abstract statement of election expenses and supporting affidavit in the prescribed form. No return of expenditure will be accepted as complete without the abstract statement of election expenses and the affidavit.
- Vouchers may not be attached only in respect of those items which are listed in rule 66(2) of the Conduct of Election Rules, 1961. For any voucher not attached vide this rule, an explanation to the effect why it was not practicable to obtain the required vouchers must be given in the prescribed register.
- The account and abstract statement shall be countersigned by the candidate if it is lodged by his election agent and should be certified by the candidate himself to be the correct copy of the account kept. The account should be sworn by the candidate himself.
- Apart from the expenses incurred or authorized by the candidate/election agent directly, all expenditure incurred or authorized by the political party, other associations, bodies of persons, individuals in connection with the election of the candidate are also required to be included in the account. The only exception is the expenses incurred on travel of elected leaders of the political party on account of their travel for propagating the programme of the party. (See explanation 1 & 2 of Section 77(1) of the Representation of the People Act, 1951)
- If the expenditure on any item shown above in column 2 and 3 above is incurred/authorized by any political party/association/body of persons/any individual (other than the candidate or his election agent), his name and complete address must be shown in column 7 and 8.
- The total expenditure referred in column 2 and 3 of the above table should include all expenditure in cash and the value of all goods and services received in kind by candidate or his election agent from any source.
- This register should include Cash Register as mentioned in Part B in Pink pages and Bank Register as mentioned in Part C in Yellow pages, as per formats prescribed.
