**"AUCTION NOTICE"**



**TERMS & CONDITIONS**

1. All the bidders should have to deposit an earnest money of Rs.5000/- Cash for each vehicle at Nazir Branch (Room No. 204) of this office/on the spot before starting the bidding process. Otherwise bidder may not be considered for participating in auction process. EMD of unsuccessful bidder shall be returned on same day whereas the EMD of successful bidder shall be returned after removal of vehicles from the spot.
2. The highest bidder will deposit total/full amount of bid at the spot on the fall of hammer otherwise, the earnest money shall be forfeited by the Committee and his bid will be cancelled.
3. The Committee reserves the rights to accept or reject the bid without assigning any reasons. In case of any dispute related to auction the decision of the Committee will be final.
4. The highest/successful bidder shall be responsible to remove the auctioned vehicles from the premises of Revenue Department immediately on the same day or within 48 hours of depositing the money at their own expenses..
5. The successful bidder shall be fully responsible for the watch and ward of the auctioned vehicles.
6. The highest bidder shall deposit 18% GST of the total bid in to the Govt. Treasury and a copy of Challan in token of having deposited the tax shall be furnished to this office for record.
