**Terms & conditions :-**

1. He will have to produce the following certificates:-
  - a) Medical certificate of physical fitness from the Medical Officer.
  - b) Attested copy of Educational Qualification Certificates.
  - c) Bonafide Himachali Certificate.
  - d) Character Certificate.
  - e) SC/ ST/OBC Certificate.
2. He will have to take an oath of allegiance/faithfulness to the Constitution of India.
3. He will have to serve anywhere in Mandi District.
4. His appointment will be subject to verification of his character.
5. He will be on probation for a period of two years in the first instance.
6. If married, he will have to furnish a certificate to the effect that he has not more than one living spouse.
7. His services will not be governed under the Central Civil Services (Pension) Rules, 1972.

If he accepts the offer on the terms and conditions as prescribed above, he should report for duty along with above documents in his respective place of posting, within 7 days, failing which the offer shall be treated as cancelled.


