
Regarding offering rates of Rooms for SARAS Fair w.e.f. 22nd February 2020 to 2nd March 2020.

It is to inform you that this office requires approximately 60 nos. of Hotel rooms and Dormitory for participants of SARAS Fair – 2020 w.e.f. 22/02/2020 to 02/03/2020. If you are interested to provide your Hotel Rooms for the SARAS Fair participants, you may attend the office of Additional Deputy Commissioner, Mandi on 15/02/2020 at 3.00 PM for negotiations of rates and Terms & Conditions.

The terms and conditions for taking rooms for above fair is given below:


1. The Hotel should be registered with the Department of Himachal Tourism. The hotel owners should bring their latest approved tariff of their hotel rooms and copy of registration certificate.
2. The detail of Super Deluxe, Deluxe, Semi Deluxe and Ordinary rooms should also be brought during negotiations.
3. The DRDA can hire rooms from more than one hotel owners, if 60 rooms are not available with one hotel owner.
4. The owner of the hotel should have minimum 10 rooms in their hotel and should be easily approachable from road.
5. The Hotel should be situated nearby Mandi Town, with parking facility.
6. All the rooms should be with attached toilet facility. The Toilet attached to the rooms should be equipped with Geyser, wash basin, European/Anglo Indian seat.
7. Daily cleaning and changing of bed sheet is required.
8. The Committee members of Distt. Rural Development Agency, Mandi will visit and verify the location and rooms of the hotel before booking the hotel of successful bidders.
9. The requirement of rooms can be increased or decreased as per the requirement.
10. If any of the beneficiary checkout from the hotel room, the owner has to inform the committee in written and no payment will be paid for room vacated before closing of the SARAS Fair.
11. The Additional Deputy Commissioner Mandi reserves the right to reject any or all the proposals without assigning any reason.
