"ORDER UNDER SECTION 144 Cr.PC."

Whereas, it has been brought in to the notice of the undersigned by the Health Authorities that a positive case of COVID-19 has been found in village Gram Panchayat Diargi, of Tehsil Balh in District Mandi. Therefore, there is as eminent danger of spread of COVID-19, in the other parts of Sub Division Balh and District Mandi and to take strict measures to stop the further spread of COVID-19, has become inevitable, which if not taken immediately can danger human life and safety.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under Section 144 of The Code of Criminal Procedure, 1973.

And, therefore, in view of the above circumstances and as a containment measure I, Dr. Ashish Sharma(H.A.S.), Sub-Divisional Magistrate, Sub- Division Balh, Distt. Mandi (Himachal Pradesh), in exercise of the power vested in me under Section 144(1), of The Code of Criminal Procedure, 1973, do hereby order and direct COMPLETE SEALING OF THE AREA OF GRAM PANCHAYAT DIARGI TEHSIL BALH, DISTRICT MANDI IN THE FOLLOWING MANNER TILL FURTHER ORDER:-

It is further ordered that:-

1. UNDER NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/IGRESS OF ANY PERSON OR VEHICLE IN THE CONTAINMENT ZONE except for persons/vehicle involved in enforcement of containment plan, essential services and medical emergency.

All the relaxations given vide order NO. MND-DM-LA/2020-3788-3846 dated 31st May, 2020, are hereby withdrawn from the containment zone given above as per the direction of Worthy Deputy Commissioner Mandi.

The issue of essential goods in the containment zone shall be done by authorities through Home delivery.

4. No. person shall leave their homes on foot or through vehicle or travel or move around, roam around or stand on any public path or place in the aforementioned containment zone.

This order shall come in to effect immediately for the entire area of above mentioned containment zone and shall remain in force till further orders.

Any violation of this order will attract provisions of Sec. 188 Indian Penal Code and the violator can also be prosecuted under section 269 and 270 of Indian Penal Code.
