Whereas, one positive case of covid-19 was found in Ward No. 5 Palace Colony of Nagar Parishad Mandi, Tehsil Sadar in District Mandi in this Sub Division and to enforce the containment measures an order under section 144 Cr.P.C. has been issued vide no. MND-SDM-Sadar-Covid-19/2020-3203-3219 dated 22nd July, 2020 and containment plan had been enforced. As reported by health authorities, ACF survey has been completed in containment zone and no new case has been found in the containment zone after 14 days from the enforcement of containment plan.
