ORDER UNDER SECTION 144 Cr.PC

Whereas, one positive case of covid-19 was found in Village Bahalidhar, Ward No. 1 of Gram Panchayat Dhar, Tehsil Sadar in District Mandi in this Sub Division and to enforce the containment measures an order under section 144 Cr.P.C. has been issued vide no. MND-SDM-Sadar-Covid-19/2020-4358-74 dated 2<sup>nd</sup> August, 2020 and containment plan had been enforced. As reported by health authorities, ACF survey has been completed in containment zone and no new case has been found in the containment zone after 14 days from the enforcement of containment plan.

Now, therefore, in exercise of the power vested in me under section 144(5), of the Cr.P.C. 1973, I, Nivedita Negi I.A.S., Sub Divisional Magistrate, Sadar Mandi, District Mandi do hereby **withdraw** the above order issued vide no.
