ORDER UNDER SECTION 144 Cr.PC

Whereas, one positive case of covid-19 was found in Ward No. 5-Sain Mohalla (Premises of the house of Sh. Lalit Kumar Rana & under construction building of Sh. Dinesh Kumar) of Nagar Parishad Mandi, Tehsil Sadar in District Mandi in this Sub Division and to enforce the containment measures an order under section 144 Cr.P.C. has been issued vide no. MND-SDM-Sadar-Covid-19/2020-4044-59 dated 24<sup>th</sup> July, 2020 and containment plan had been enforced. Subsequently four more cases were reported in the containment zone. The health authorities have reported to the undersigned that active case finding survey has been completed, reports of all the people whose sample had been collected were reported negative and there are no persons with Ill symptoms in the containment zone.

Now, therefore, in exercise of the power vested in me under section 144(5), of the Cr.P.C. 1973, I, Nivedita Negi, Sub Divisional Magistrate, Sadar Mandi, District Mandi do hereby **withdraw** the above order issued vide no. SDM/MND/SDR/Covid-19/2020-4044-59 dated 24<sup>th</sup> July, 2020
