Whereas, one positive case of covid-19 was found in Village Majhwar Ward No. 4 of Gram Panchayat Majhwar, Tehsil Sadar in District Mandi in this Sub Division and to enforce the containment measures an order under section 144 Cr.P.C. has been issued vide no. MND-SDM-Sadar-Covid-19/2020-4883-98 dated 13th August, 2020 and containment plan had been enforced. As reported by health authorities, ACF survey has been completed in containment zone and no new case has been found in the containment zone after 14 days from the enforcement of containment plan.
