ORDER

UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT 2005

WHEREAS, recent mutation of SARS-CoV-2 variant (B.1.1.529; named (Omicron) has been reported from South Africa on 24th November, 2021 and subsequently COVID positive cases of the same variant has been reported from various States of the Country including Himachal Pradesh;

WHEREAS, Omicron variant of COVID-19 has been classified as Variant of Concern by the World Health Organization and in order to curtail the spread of the new variant, there is a dire need to take some preventive measures;

WHEREAS, there are reports of sharp rise in the number of COVID-19 positive patients in the District which has necessitated to take some precautionary measures on emergent basis;

WHEREAS, the Chief Secretary-cum- Chairman, State Executive Committee, Himachal Pradesh vide his office order no. Rev (DMC) (C) 20-2/2022- COVID-19, Dated 05th January, 2022 has imposed certain restrictions in the State in order to restrict the spread of COVID -19;


THEREFORE, I, Arindam Chaudhary, Chairman, District Disaster Management Authority-cum-District Magistrate, Mandi in compliance to the directions passed by the Chief Secretary-cum-Chairman, State Executive Committee, Himachal Pradesh and in welfare of the public at large and in exercise of the powers vested in me under section 34 of the Disaster Management Act, 2005 do hereby order and direct that:

1. "No Mask-No Service" policy will remain operational in the District.
2. There shall be **Night Curfew** in the District from 10:00 PM to 5:00 AM.
3. In all indoor/covered areas and open spaces including marriage palaces & banquet halls, for all **social/ academic/ sports/entertainment/ cultural/ political/ religious and other congregations** are allowed with **50% of the capacity** subject to adherence of the COVID-19 safety protocols and COVID appropriate behaviour.
4. **Hotels & Restaurants** shall remain open subject to strict adherence to COVID Appropriate Behaviour.
5. **Cinema Halls/Multiplex/Sports Complex/Stadiums/Swimming Pools/ Gymnasiums** shall remain closed till further order.

6. No **langar** shall be allowed in religious places/places of worship in the District.

COMPLIANCE to this order shall be ensured by the Superintendent of Police, Mandi, all Sub Divisional Magistrates, Mandi, Chief Medical Officer, Mandi, all Executive Magistrates, Mandi, all Block Medical Officers, Mandi, and public at large. Violation of the order shall attract provisions of section 51-60 of Disaster Management Act, 2005 and the violator shall be prosecuted accordingly.
