**ORDER**

In continuation of order No. 10104-10206/MA/COVID-19 Dated 27-11-2020 and 10316-10336/MA/COVID-19 Dated 15-12-2020 vide which night curfew, restriction on timings of hotels, restaurants, marriage palaces etc., ceiling on indoor (100 persons) and outdoor (250 persons) social gatherings and restrictions for Covid-Appropriate behaviour were imposed upto 31<sup>st</sup> December, 2020.



Now Govt. of Punjab, Department of Home Affairs and Justice, Chandigarh has issued new guidelines vide letter No.7/56/2020/2H4/5120 dated 29-12-2020.

In light of the above I, Dr. Shena Aggarwal, IAS, District Magistrate, Shahid Bhagat Singh Nagar in exercise of the powers conferred upon me under section 144 Cr.P.C., 1973 order that restrictions regarding night curfew (10pm to 5 am) in all cities/towns and closing down hotels, restaurants, marriage palaces etc. by 9.30 pm in the district shall continue upto 31st December 2020, both these restrictions shall no more be applicable w.e.f. 1st January, 2021 onwards.

Ceiling of 100 persons and 250 persons in all the indoor and outdoor social gatherings in the district applicable upto 31st December 2020 also stands further relaxed to 200 persons and 500 persons in all the indoor and outdoor social gatherings respectively w.e.f. 1st January, 2021 onwards.

There shall be strict implementation of all the extant directives of MHA/State Government including keeping social distancing of minimum 6 feet distance (do gaz ki duri), regulating crowds in market and public transport and imposition of penalties prescribed for violation of Covid-Appropriate behaviour like wearing of face masks and spitting in public places etc.


Senior Superintendent of Police, Shahid Bhagat Singh Nagar, Sub Divisional Magistrate, Nawanshahr/Banga/Balachaur, Civil Surgeon, Shahid Bhagat Singh Nagar, Secretary, Regional Transport Authority, Hoshiarpur, General Manager, Punjab Roadways, Shahid Bhagat Singh Nagar and Assistant Excise & Taxation Commissioner, Shahid Bhagat Singh Nagar will responsible for compliance of this order.
