Subject: Filing of counter affidavits and other documents in the courts.

Sir,

I am directed to address you on the subject noted above and to say that Advocate General, Punjab, vide D.O. No.8126 dated 18.12.2006 has conveyed to the Government, the guidelines given by the Hon'ble Chief Justice of Punjab and Haryana High Court regarding filing of counter affidavits and the documents forming enclosures to the same and also regarding the personal appearance of the Government officials before the Hon'ble High Court, as follows:-

- (1) Counter Affidavit to Writ petition be filed within the time granted by the court in the Registry.
- (2) No counter-affidavit/document will be accepted in Court.
- (3) Time for filing counter affidavit will not be extended.
- (4) Written Statement will be referred to as "Counter Affidavit" and must be filed by a responsible officer who will give all details relevant for a decision in the matter.
- (5) Reference to documents will be made through page numbers and not Annexure Nos. Thus all paper book be page marked.
- (6) Wherever sketches/maps are annexed these should be on legal size paper only, if this is not possible, with large sheets be filed.
- (7) Government officials who are asked to appear in person must be suitably attired i.e. uniform or formal wear.

These guidelines/instructions may be adhered to strictly.
