Order

Whereas in exercise of power conferred under section 144/IPC for the containment of epidemic COVID-19, an order vide Letter no. 3062-85/MC.4/MA Dated: 23.03.2020 was Issued regarding implementation of Curfew in Jalandhar.

Whereas keeping the current situation of COVID-19 in Jalandhar and in light of guidelines given by Govt. of Punjab, Department of Home Affairs and Justice letter no. SS/ACSH/2020/313 Dated 18th April 2020 and SS/ACSH/2020/336 Dated 29th April 2020 and Govt. of India guidelines No. 40-3/2020-DM I(A) Dated 15th April-2020 to mitigate hardship to the public,

I, Varinder Kumar Sharma, IAS, District Magistrate, Jalandhar in continuation of the order no. 6437-56/MC.4/MA dated 20.04.20 allow the Industrial Activities w.e.f. 30th April-2020 as described under:

1. All the industries located in rural areas i.e. out of Municipal Corporation/ Committee/ Nagar Panchayats limit, in all Focal Points, in all Industrial Areas, in all Industrial Estates and all Industrial Townships and Industrial Clusters Situated within the jurisdiction of district Jalandhar will be allowed to resume their operation but except in containment zones as notified by undersigned by various orders issued from time to time. For clarity it is repeated that Industrial activities in containments zones as declared by undersigned through order issued from time to time shall be strictly prohibited. Any body found running any industrial activities in any of the containment zones will be prosecuted as per law.
2. No specific approval or permission from any district authority would be required for restarting the operations by the industry in permissible areas as explained in Para-1 above.
3. If the industry is satisfied that they have made adequate arrangements for implementation of SOP, they have to send a self- declaration regarding this at GMDIC, Jalandhar office via email ID: **gmdicjal@yahoo.com** before starting their operation.
4. The bulk passes for movement of factory workers (if done by Bus or such vehicles) will be issued by GM-DIC, Jalandhar. The movement of labour will also be permitted on foot or by cycles, for issuance of passes for labour, the factory owner will submit a list of workers along with their Adhar Card Numbers to the GM-DIC, Jalandhar and get it approved and countersigned from GM, DIC, Jalandhar. These bulk passes will be validated along with a photo ID card of the holder. The factory worker will have to produce any identity card along with photocopy of bulk passes list approved by GM, DIC, Jalandhar which will act as curfew pass. (The Performa for self declaration is attached.)
5. The movement e-passes for management and official staff along with their vehicles will be taken online from **epasscovid19.pais.net.in**. While applying for e-pass, the management and staff will have to upload the self-declaration as supporting document. These e-passes shall be approved by GM, DIC, Jalandhar.
6. The movement of factory workers will be restricted to the given timings as under:
Morning 7AM To 9AM Evening: 5PM to 7PM
