**Order**

The Corona virus has spread terror throughout the world which has been declared as an epidemic by the State Government. It has begun spreading itself in India, thus the prevention of this is very important. In this regard, vide this office letter No. 3062-85/MC-4/MA dated 23.03.2020 curfew order in the district Jalandhar was issued.

Now I, Varinder Kumar Sharma, IAS, District Magistrate, Jalandhar in exercise of powers conferred upon me under section 144 of CrPc 1973 allow certain relaxation in curfew.

***However, these relaxations will not be given in Containment Zones.***

It is hereby ordered that:-

The Restaurants, Eateries, Halwais, Ice Creams Shops, Juice shops & Bakery Shops in District Jalandhar are allowed to open from **7 AM to 6 PM ONLY FOR HOME DELIVERY** subject to the condition:-

1. Dining will not be allowed.
2. Hygiene standards to be maintained at workplace:
  - a. Restaurants have to record temperature of all employees coming to the restaurant on a daily basis and maintain record of that.
  - b. Frequent cleaning/disinfection of work surfaces and touch points such as door handles.
  - c. Face mask is mandatory for all employees and must be changed every day.
  - d. Maintain social distancing while at work.
  - e. Frequent hand washing and use of hand sanitizers to be practiced.
3. Guidelines to be followed during home delivery of food:-
  - a. The Deliverable food item should be packed hygienically.
  - b. Delivery/transport vehicles shall be cleaned and sanitized regularly.
  - c. Zero contact delivery while delivering food to the guest and contact with common touch points such as door bell should be avoided.
  - d. Face mask/Gloves are mandatory for all delivery workers.

These guidelines are illustrative and not exhaustive. All concerned to follow the COVID-19 Management guidelines issued by government from time to time.

Anyone found violating the COVID-19 guidelines will be liable for strict action under the provision of National Disaster Management Act, 2005 and The Indian Penal Code, 1860.
