**ORDER**

Inj. Remdesivir 100 mg and Tocilizumab is being issued for management of COVID-19 patients. The State Govt. has decided to provide the injection from the Govt. Stock to designated Government & Private COVID Care Centres / Chemists situated inside Private Covid Care Centre.

2. In order to facilitate the availability and to have a check on the Remdesivir Injection and Tocilizumab Injection provided from the Govt. Supplies to the various health facilities, it is decided that:-


- (1) The supplies received by the Government at the Central Store shall be allocated to all the districts of the Punjab for further supply to the (i) Government Covid Care Centres (ii) Private Covid Care Centres / chemists situated inside Private Covid Care Centre.
- (2) For supply to the Private Covid Care Centres / chemists situated inside Private Covid Care Centre, the committee shall be constituted at the District Level comprising representative of Deputy Commissioner, Civil Surgeon and Zonal Licensing Authority / Drugs Control Officer will decide the distribution.
- (3) The payment of the injections supplied to the Private Covid Care Centres / chemists situated inside Private Covid Care Centre shall be made in a separate bank account of Punjab Health Systems Corporation (PHSC). Bank account details are as under:-

- (4) The prices to be charged from the Private Covid Care Centres / chemists situated inside Private Covid Care Centre shall be the same at the rate procured by the National Health Mission. The details of the current prices of various companies are as below: -
