TERMS & CONDITIONS.

1. The rate should be quoted for detention per day and per K.M. as per format given at ANNEXURE-A.
2. The valid documents i . e. Road Tax, Road Permit, Registration, Insurance, Pollution Certificated, Commercial Registration etc. Should be submitted along with the tender as per Motor Vehicles Act.
3. The Vehicle must be registered in the year 2017 model or latest.
4. Amount should be written both in figures and words.
5. Providing fuel, lubricants, dusters and maintenance etc for the cars will be responsibility of the supplier/owner
6. The Vehicle should be placed with in 03(three) days from the date of Issue of final order.
7. The Driver should be given prescribed Liveries by the supplier.
8. In case of need, the Driver has to be changed within 24 hours of being informed and if the car is not available on any day no payment (detention charge) would be made for the day and also for the next day.
9. In case of repair, a similar car shall have to be provided by the supplier as replacement during repair.
10. Payment of hiring charges will be on monthly basis against bills raised by the supplier supported by appropriate signature of Log Book from the user.
11. Necessary tax will be deducted from the bills as per rule.
12. The Owner concerned shall arrange the garage of the vehicle locally at his one cost & responsibility.
