NOTICE INVITING TENDER

On behalf of the Governor of Tripura, sealed tender is hereby invited by the undersigned from the CAG empanelled Chartered Accountancy (CA) firms for auditing of MGNREGS accounts of 169 GP/VCS, 7 R. D. Blocks and 15 line departments of Sepahijala District for the financial year 2018-19. Auditing of the concerned GP/VC and line departments can be done centrally at headquarters of concerned R D blocks. Bidders should quote their rate both in figures & words on plain paper, including GST/applicable taxes, along with requisite documents. Any incomplete bid shall summarily be rejected. Any firm/bidder blacklisted by any government department/agencies shall not take part in the bidding process.

Tender shall be dropped only in the designated tender-box kept in the office chamber of the Sr.Dy.Collector (DDO & HoO), Office of the DM & Collector, Sepahijala District, Bishramganj, between 11.00 a.m. and 5.00 p.m. on all working days **from the 26th June 2019 to the 3rd July 2019**, and the same **will be opened on the 4th July 2019 at 3.00 p.m.**, unless rescheduled due to any exigency, during which the tenderers or their representatives may be present. If for any unforeseen reason it becomes impossible/inconvenient to receive tender on the last day fixed for the purpose, the working day immediately following shall be deemed to be the last day of receiving tender.



Terms and conditions:-

1. The auditing should have to be completed within 20(twenty) days from the date of issuance of work order.
2. Document showing currently valid CAG empanelment shall be enclosed along with tender.
3. The firm shall submit a certificate stating that it has not been blacklisted by any government department/agency.
4. 3(three) sets of audit report have to be delivered within 3(three) days from the date of completion of audit, else penalty @ 1% on contract amount shall be recoverable per day of delay.
5. Rate should be quoted distinctly both in figures and words separately including all taxes. No overwriting or erasing shall be admissible.
6. No advance payment shall be made.
7. GST registration (permanent/provisional)certificate/PAN Card are mandatory for dropping the tender (self-attested photocopy to be enclosed along with the tender, and original thereof to be produced when asked for after opening the tender).Tender without these enclosure shall be rejected.
8. The sealed quotation shall exclusively be dropped in the designated tender-box kept in the office chamber of the Sr. Dy. Collector (DDO & HoO), DM's Office, Sepahijala District, Bishramganj on all working days upto **3rd July 2019** between 11.00 a.m. and 5.00 p.m. every day.
9. The undersigned reserves the right of accept or reject any tender/quotation including the lowest one without assigning any reason whatsoever.
10. Other residual terms and conditions as mentioned in the Press Notice Inviting Tender shall be deemed to the integral part of the terms and conditions of this tender.
