The above mentioned officers are directed to ensure that,

- *there is no violation of Code of Conduct in assigned LACs and each and every electioneering activities by the candidates and Political parties are according to the prevalent directions of the Election Commission of India.*
- *always be in liaise with Nodal Officer for E E M and Nodal Officer for c VIGIL. c VIGIL application is a newly introduced online application for citizens to report violation on Model Code of Conduct / Election expenditure during the period of election. If the petition/complaints raised and forwarded from c VIGIL with a nature of M C C violation shall immediately be processed. If the nature of petition is to be escalated to higher authority, the same shall be done with report to Nodal Officer, Model Code of Conduct / Returning Officer without any delay.*
- *An LAC wise candidate-wise register is maintained to track the instances of violations committed by various candidates / campaigners of various political parties. Nature of the register should have name of the candidate, campaigner, political parties, date of violation, brief description of violation, follow up action taken. The index of such violations shall be placed in a public domain so that interested parties including the media can pick up the input so as this may work as a deterrence for candidates / political parties against indulging in further violations.*
- *The team shall work in liaise with field squads duly constituted for seizure of cash, illicit liquor etc in District.*
- *dos and don'ts framed by Election Commission of India is complied.*

If necessary the squads appointed can also avail the help from the Police Authorities in their jurisdiction concerned with duly reporting to the *Nodal Officer, Model Code of Conduct / Assistant Returning Officer of the respective L A Constituency.* Moreover, the Officers are also directed to send a daily report to **Sri. S. Prem Krishnan I A S, Assistant Collector (U/T), Thrissur & Nodal Officer for**

**Model Code of Conduct before 9.30am. on each day without fail.** Sri. Rajesh Marath, Junior Superintendent, Spl Tahsildar (LA) No 1, Thrissur assigned in District Level Team for MCC is directed to co-ordinate the reports from all designated officers appointed in L A Constituencies.

The Nodal Officer shall submit daily report in Annexure II directly to Chief Electoral Officer with a copy to District Election Officer.
