Vide read 1 above in connection with the General Election to Lok Sabha 2019 Deputy Commissioner, State GST has already been appointed as Nodal Officer for Election Expenditure Monitoring in District. Vide read 2 above 3 Nos. of Flying Squad and Static Surveillance Team for each LA Constituencies has already been formed in District. Vide read 3, 4 above Accountant General, Thrissur has forwarded the details of Officers to be appointed as Assistance Expenditure Observers for each LAC in District. As such following officers are appointed as Assistant Expenditure Observers in LA constituencies in District.

- The above appointed officers shall start performing in their respective constituencies from **the Date of Notification of Election** and shall not leave the Constituency without the permission of Expenditure Observer.
- He shall ensure that all the expenditure related reports / Orders in respect of each candidate are obtained from all Squad / Teams engaged in Expenditure Monitoring and shall supervise the maintenance of Shadow Observation Register and Candidates Expenditure Register.
- He shall collect the daily Action Taken Report from Flying Squad & S S T constituted in LA Constituency and if he feels that the Squad / Team constituted are not functioning properly, the same must be immediately informed to the Expenditure Observer for remedies.
- Daily report in Annexure VI shall be submitted to Expenditure Observer with copy to District Election Officer through Nodal Officer for Election Expenditure Monitoring.
- He shall collect the data / complaints if any related with his Legislative Constituency from Media Certification and Monitoring Committee and Monitoring Control Room / Call Center operating in District Head Quarters.
- The Officers designated shall ensure that the activities done by the Squads / Teams constituted are strictly complying the Instructions / Guidelines given by Election Commission Of India.
- The Officers designated shall ensure that Executive Magistrates appointed in Flying Squad /Static Surveillance Team are always in liase with Nodal Officer for E E M, Assistant Expenditure Observers, Income Tax Nodal Officer and Nodal Officer for c VIGIL.
- SINCE, c VIGIL application is a newly introduced online application for citizens to report violation on Model Code of Conduct / Election expenditure during the period of election, a close watch must be done on the action taken by Executive Magistrates appointed in Flying Squad /Static Surveillance Team on a c VIGIL petition raised by citizen and see that a petition/complaints raised and forwarded from c VIGIL with a nature of Election expenditure violation shall immediately be processed by the assigned squad. See that if the nature of peti-

tion is to be escalated to higher authority, the same is done by the squad concerned with report to Nodal Officer, Election expenditure Monitoring / Returning Officer without any delay.

The Assistant Returning Officer shall provide a temporary Office with all facilities including network systems, to Assistant Expenditure Officer and the same shall function in the O/o the Assistant Returning Officer concerned. The Assistant Returning Officer shall meet with the needs of the Assistant Expenditure Officer for smooth functioning of Election.
