

GENERAL ELECTION TO LOKSABHA 2019

Proceedings of the District Collector & District Election Officer, Thrissur (Present: Anupama.T.V., IAS)

Sub: General Election to Loksabha 2019 – Appointment of Liaison Officer to assist General Observer – Order Issued.

Read: Letter dated 18.03.2019 by Sri.P.K.Senapati IAS, Secretary, Board of Revenue, Odisha.

Order No.EL1 - 144842/2019; Dated: 21st March 2019

Vide read above, Election Commission of India has appointed Sri.P.K.Senapati IAS, Secretary, Board of Revenue, Odisha as General Observer for 010 Thrissur Parliamentary Constituency in the upcoming General Election to Loksabha 2019. The appointed General Observer informed that the Officer is scheduled to arrive in District on 03.04.2019 (i.e., one day before the last date of filing nominations) and also instructed to sent vehicle with Liaison Officer.

In this circumstance Sri.Abhimannue.T.R. (Mob.No.9539473852), Agricultural Officer, Krishibhavan, Pananchery and Sri.Dipin.M.N. (Mob.No.9383471194), Agricultural Officer, Krishibhavan, Panjal are appointed as Liaison Officers to Sri.P.K.Senapati IAS, Secretary, Board of Revenue, Odisha and General Observer for 010 Thrissur Parliamentary Constituency with immediate effect. The Liaison Officers appointed shall ensure that facilities such as transportation, lodging, boarding etc., for General Observer are timely done as per the instructions provided by Election Commission of India from time to time.

General duties of the Liaison officers appointed for General Observer shall

- collect Observer's kit for General Election to Loksabha 2019 from Smt.T.R.Maya (Mob.Nos.9495098597, 9846486999), Nodal Officer for Observers & District Planning Officer, Thrissur;
- ensure that facilities are arranged for Observer as per guidelines of ECI at Observer's camp office;
- make arrangements for daily submission of Press releases of English dailies and brief reports of local dailies related to Election matters such as MCC, Defacement, processions, rallies, etc., to Observer;
- make a daily progress note from Collectorate and inform details to observer including meetings, video Conferences etc. scheduled by DEO / CEO / ECI;
- liaise with the Police authorities and get detailed notes on meetings, processions of political parties / Candidates on daily basis.;
- watch visual Media and make notes on Violations of MCC, electoral offences, defamation, verbal threats of candidates / leaders of political parties, political party hooliganism if any, reported by any local language channel and makes note to Observer;

- ensure that special counter with specified communication facility is set up for observer before the poll day;
- collect and compile information from Returning Officer's table and submit to observer as and when instructed;
- prepare observer's report on directions of Observer and
- ensure that any direction given by Observer in due course is complied in time.
