

GENERAL ELECTION TO LOKSABHA 2019

Sub: General Election to Loksabha 2019 – Appointment of Liaison Officer to assist Expenditure Observer – Order Issued.

Ref: Information from Sri.S.Renga Rajan IRS, Assistant Commissioner of Income Tax, Chennai.

As per reference cited above Sri.S.Renga Rajan IRS (Mob.No.9445954081), Assistant Commissioner of Income Tax, Chennai appointed as Expenditure Observer for 010 Thrissur Parliamentary Constituency in the upcoming General Election to Loksabha 2019 and as such the appointed Expenditure Observer informed that the Officer is scheduled to arrive in District on 27.03.2019 (i.e., one day before the date of notification) and also instructed to sent vehicle with Liaison Officer.

In this circumstance Sri.Vineeth.K.M. (Mob.No.8281040579, 9961177674), Block Development Officer, Chavakkad Block, Chavakkad and Sri.Abdul Salam (Mob.No.9946538683), Block Development Officer, Mullassery Block, Mullassery are appointed as Liaison Officers to Sri.S.Renga Rajan IRS, Assistant Commissioner of Income Tax, Chennai, Expenditure Observer for 010 Thrissur Parliamentary Constituency with immediate effect. The Liaison Officers appointed shall ensure that facilities such as transportation, lodging, boarding etc., for Expenditure Observer are timely done as per the instructions provided by Election Commission of India from time to time.

General duties of the Liaison officer appointed for observer (Expenditure)

Liaison Officers shall,

- collect Observer's kit for General Election to Loksabha 2019 from Smt.T.R.Maya (Mob.Nos.9495098597, 9846486999), Nodal Officer for Observers & District Planning Officer, Thrissur;
- ensure that facilities are arranged for observer as per guidelines of ECI at Observer's camp office;
- make arrangements for daily submission of Press releases of English dailies and brief reports of local dailies related to Election expenditure matters such as seizure of cash, valuable items, details of VVIP visits, processions, rallies, stage shows, etc.;
- make a daily progress note from Collectorate and inform details to observer including meetings, video Conferences etc. scheduled by DEO / CEO / ECI;

- liaise with Nodal Officer of Election Expenditure Monitoring and notes on expenditure incurred by the candidate from time to time and submit details to the observer;
- liaise with the Police authorities/Returning Officer of respective LA Constituency / Assistant Expenditure Observer and get detailed notes on sanctions of vehicles, meetings, processions of political parties / Candidates on daily basis;
- watch visual Media and make notes on paid news found if any, and liaise with MCMC member Secretary - Nodal Officer & District Information Officer for collecting data regarding election expenditure;
- watch cVigil complaints and action taken by the Flying Squad and Assistant Returning Officer concerned regarding the expenditure related petitions and ensure that complaints are rectified in stipulated time specified by Election Commission of India as per directions of Expenditure Observer;
- monitor the GPS activities of Flying squads and check posts of Static Surveillance Team of respective LA Constituencies and make detailed note to Observer. If any discrepancy in activities of Flying Squad / SST is found, the same shall be informed to the Observer concerned and DEO;
- the video clippings made by Video Surveillance Team on meetings, processions etc. for election campaign shall be monitored and reports shall be given to Observer;
- prepare observer's report on directions of Observer;
- ensure that any direction given by Observer in due course is complied in time.


