**Order No: EL1 - 140031/2019 ; Dated : 02 : April : 2019**

Vide read 1 above complying directions of Election Commission of India, Sri.Abhilash.T.A, Deputy Commissioner, State Goods and Services Tax, Thrissur was appointed as Nodal Officer for Election Expenditure Monitoring in District & vide 2 above Assistant Expenditure Observers were posted in each LA Constituencies in District. Vide read 3 above, Video Surveillance Team in respective LA Constituencies were constituted in District.

Election Commission of India has directed to constitute one or more Video Surveillance Team in each LA Constituency with minimum one official along with one videographer and if necessary, more number of teams may be deployed on the recommendation of Expenditure Observer. Vide read 3 above, earlier Video Surveillance Team were constituted with three officials for each LA Constituency in District. The Expenditure Observer has recommended functioning of more units for video surveillance in HP Constituency for effective functioning of the Expenditure Monitoring System.

In the circumstance, as per the instructions of expenditure Observer, the team for each LA Constituency is split in to three independent units for LA Constituency with one official and one videographer as follows. The Assistant Returning Officer in liaison with Assistant Expenditure Observer of respective LA Constituency shall prepare an effective schedule for the single official unit, constituted for Video Surveillance from 08.04.2019 onwards.

Each Unit shall work as a single team and shall prepare a cue sheet at the time of recording in the format given in annexure 7 of the compendium of instruction on Election Expenditure Monitoring. Independently prepared cue sheet by each unit shall be forwarded to the Video Viewing Team along with the recorded CD on the next day itself. The video CD should have identification number date and name of the staff / officer and should always be kept with the Cue Sheet. Moreover, assigned officer shall comply the directions given by the Election Commission of India from time to time. Deputy Collector (Election) shall provide additional videographers and subsequent arrangements for the vehicle for the newly formed units of Video Surveillance in District. Assistant Returning Officers must share the copies of permissions given, input from other squads and sources to help them in effective deployment.

The unit shall record the sensitive and expenditure related events, evidences and big public rallies in the constituency under the supervision of Assistant Expenditure Observer. At the beginning of shooting shall record in voice mode the title and the type of the event, date, place and the name of the party and candidate organizing the event. The unit shall videograph the vehicles/ events / poster/ cut-out etc. in such a way that the evidence of each vehicle, its make and registration number, number of furniture size of rostrum, banner and cutout etc can be clearly seen and the expense there on can be calculated. Wherever possible, statements of the drivers and passengers of the vehicle should also be recorded to prove that the vehicle was used for election purpose, if such vehicles are parked outside the venue of rally.

During the shooting of the event, shall also record in voice describing the estimated number and type of vehicles, chairs/ furniture/ lights/ loud speakers etc. the approximate size of rostrum / banner/ poster/ cutout etc used in the event. The videographer will also record the speech and other events to monitor whether any MCC violation has occurred.
