Vide read 1 above in connection with the General Election to Loksabha 2019, Sri. Abhilash.T.A, Deputy Commissioner, State Goods and Services Tax, Thrissur (Mobile No: 9447786336, 9447631702) were appointed as Nodal Officer for Expenditure Monitoring and subsequently Static Surveillance Team were constituted for each L A Constituencies in District.

As per the guidelines of Election Commission of India, minimum three Static Surveillance team are to be constituted for each L A Segment and if necessary more teams shall be constituted for effective functioning of expenditure monitoring system. The Expenditure Observer assigned to Thrissur HPC instructed to constitute one more squad for Static Surveillance Team in HP Constituency so that round the clock squad work can be done more effectively in Jurisdiction area.

In the circumstance, **additional Static Surveillance Team is constituted in Thrissur HP Constituency to function from 08.04.2019 onwards. Nodal officer for Election Expenditure Monitoring Shall prepare an effective schedule with newly constituted Team so as to ensure that Teams round the clock activity is observed in 010 Thrissur H P Constituency.**

- 01: Static Surveillance Team constituted shall put check posts on major arterial roads, borders of the L A Constituencies and shall keep watch on the movement of illicit liquor, items of bribe, large amount of cash, arms and ammunition, and also movement of anti-social elements in their jurisdiction. The entire process of checking and verification shall be videographed.
- 02: The Team shall send daily activity report to District Police Chief (City)/(Rural) with a copy to General Observer / Expenditure Observer / Returning Officer / District Election Officer and to the Nodal Officer of Police (City)/(Rural) and Excise in Annexure C.
- 03: The team constituted shall strictly comply the instructions given in Annexure 73 of Guidelines of Election Commission of India and further instructions if any, in due course by E C I/ C E O
04. The team shall always be in liase with Nodal Officer for E E M, Assistant Expenditure Observers, Income Tax Nodal Officer and Nodal Officer for c Vigil. c Vigil application is a newly introduced online application for citizens to report violation on Model Code of Conduct / Election expenditure during the period of election. If the petition/complaints raised and forwarded from c Vigil with a nature of Election expenditure violation shall immediately be processed. If the nature of petition is to be escalated to higher authority, the same shall be done with report to Nodal Officer, Election expenditure Monitoring / Returning Officer without any delay.
05. The team constituted shall comply the directions / instructions published by the Election Commission of India from time to time

The above officers are directed to report before the Returning Officers concerned with immediate effect for further instructions. They are also directed to work in liaison with Sri. Abhilash.T.A, Deputy Commissioner, State Goods and Services Tax, Thrissur & Nodal Officer for Election Expenditure Monitoring in District

The Nodal Officer, Police (City)/(Rural) and Nodal Officer (Excise) for Election Expenditure Monitoring in district shall monitor the functions of the squad / teams and liaison with the Nodal Officer for Election Expenditure Monitoring. The Nodal Officer (City)/(Rural) shall consolidate all daily reports in Annexure C and forward on the very next day by Fax / e-mail to the Election Commission with a copy to Chief Electoral Officer.
