In connection with upcoming the General Election to Lok Sabha 2019 in District, vide read 1 above Sri.Abhilash.T.A, Deputy Commissioner, State Goods and Services Tax, Thrissur was appointed as Nodal Officer for Expenditure Monitoring and vide 2, 3 above Static Surveillance Teams for each LA Constituency, and additional team for Thrissur H P constituency were constituted under the supervision of Executive Magistrate. Vide read 4 above, considering the request of Nodal Officer for Expenditure Monitoring, interchange of Executive Magistrate Order were issued in between 066 Ollur L A Constituency and 071 Puthukkad LA Constituency.

Vide read 5 above, Nodal officer for Election Expenditure Monitoring has requested to cancel interchange order of Executive Magistrates as Sri. Dinesh M K, Secretary, Cherpu Grama Panchayath assigned as Executive Magistrate in 071 puthukkad LA Constituency is physically not fit for performing duties of Executive Magistrate.
