Vide read 1 above in connection with the General Election to Loksabha 2019, Sri. Abhilash.T.A, Deputy Commissioner, State Goods and Services Tax, Thrissur (Mobile No: 9447786336, 9447631702) were appointed as Nodal Officer for Expenditure Monitoring and vide read 2 above Flying Squad were constituted for each L A Constituencies in District.

As per the guidelines of Election Commission of India, minimum three Flying Squads are to be constituted for each L A Segment and if necessary more squads shall be constituted for effective functioning of expenditure monitoring system. The Expenditure Observer assigned to Thrissur HPC instructed to constitute one more Flying Squad in HP Constituency so that round the clock squad work can be done more effectively in Jurisdiction area.

In the circumstance, **additional Flying Squad is constituted in Thrissur HP Constituency to function from 08.04.2019 onwards. Nodal officer for Election Expenditure Monitoring Shall prepare an effective schedule with newly constituted Team so as to ensure that Teams round the clock activity is observed in 010 Thrissur H P Constituency.**

- 01: Flying Squad constituted for keeping vigil over excessive campaign expenses, distribution of items of bribe in cash or in kind, movement of illegal arms, ammunition, liquor or anti-social elements etc. in the constituency during election process. Daily activity Reports are to be furnished by the Flying Squad and Static Surveillance Team in the formats enclosed with it. Members of each Flying Squad and Static Surveillance Team to the extent possible should not be assigned duty for more than 8 hrs. in a day and are to be dismantled immediately after poll/re-poll.
- 02: The Flying Squad shall (a) attend to all model code of conduct violations and related complaints; (b) attend to all complaints of threat, intimidation, movement of anti social elements, liquor, arms and ammunition and large sum of cash for the purpose of bribing of electors etc; (c) attend to all complaints regarding election expenditure incurred or authorised by the candidates/political party; (d) video-graph with the help of Video Surveillance Team (VST) all major rallies, public meeting or other major expenses made by political parties after the announcement of election by the Commission.
03. The Flying Squad shall always be in liase with Nodal Officer for E E M, Assistant Expenditure Observers, Income Tax Nodal Officer and Nodal Officer for c VIGIL. c VIGIL application is a newly introduced online application for citizens to report violation on Model Code of Conduct / Election expenditure during the period of election. If the petition/complaints raised and forwarded from c VIGIL with a nature of Election expenditure violation shall immediately

be processed. If the nature of petition is to be escalated to higher authority, the same shall be done with report to Nodal Officer, Election expenditure Monitoring / Returning Officer without any delay.

Whenever a complaint regarding the distribution of cash or liquor or any other item is received, the flying squad shall reach the spot immediately and gather necessary evidence, seize the items of bribe, gather evidences and record statement of the witnesses and persons. The Magistrate of Flying Squad of the team will send a report immediately to the Nodal Officer, Election Expenditure Monitoring with a copy to District Election Officer, Assistant Returning Officer, District Police Chief (City)/(Rural), General and Expenditure Observers, Assistant Expenditure Observers in Annexure A . The entire proceedings shall be video graphed. Whenever complaints related to violation of Model Code of Conduct noticed Flying Squad should conduct an enquiry about the complaint. The Magistrate should also submit daily report duly signed and shall sent daily activity report as per Annexure A, Annexure B to District Election Officer, Nodal Officer for Model Code of Conduct and Assistant Collector (U/T), with a copy to the District Police Chiefs, Returning Officers, General Observers and Expenditure Observers on very next day.

The above officers are directed to report before the Returning Officers concerned with immediate effect for further instructions. They are also directed to work in liaison with Nodal Officer for Expenditure Monitoring & Deputy Commissioner, SGST, Thrissur

The Nodal Officer, Police (City)/(Rural) and Nodal Officer (Excise) for Election Expenditure Monitoring in district shall monitor the functions of the squad / teams and liaison with the Nodal Officer for Expenditure Monitoring & Deputy Commissioner, SGST, Thrissur
