In connection with the General Election 2019, Flying Squad, Static Surveillance Team, Video Surveillance Team, Video Viewing Teams for each L A Constituency has been constituted as per Election Commission of India's guidelines, for smooth functioning of Electioneering vide orders read above.

As per the General instructions by **Election Commission of India the squad/team constituted shall be dismantled immediately after the Poll. The Poll date for General Election 2019 in State of Kerala is scheduled on 23.04.2019.**

In these circumstances, the squad/teams constituted in various orders cited above shall be dismantled after close of poll procedures on the day of Poll. Executive Magistrates / Team leaders of each squad/team are directed to submit all the records to Nodal Officer for Election Expenditure Monitoring & Deputy Commissioner, State Tax (SGST), Thrissur after dismantling of the squad/team. The report of dismantling the squad/team shall be consolidated by the Nodal Officer for Election Expenditure Monitoring & Deputy Commissioner, State Tax (S G S T) and submit the same to this Office for further procedure. In case if a re-poll occurs, the Squad/Team of the particular Segment shall act till the completion of re-poll.

It is also to notice that if any exigencies occurred, the team will be immediately reconstituted for further action.
